The Canning Art Award is a Selected Work exhibition. All works submitted are judged, however only those selected by the judging panel will be on display.

Conditions of Entry

1. Cost of nominations (non-refundable)
Youth 13-18 years \$5 per entry
Adults \$15 per entry
2. All nominations are to be submitted for pre-selection.
Closing date for nominations is Friday 19 March 2010. No late entries will be accepted.
3. Applicants are to submit:
 - A completed application form including entry fee, which must show name, address, phone number, email address (if applicable), photograph number, title, section and price.
 - Photographs (maximum size 10 x 15 cm) of the actual artwork being entered:
 - » Up to three photographs of each artwork entered are allowed (e.g. one image of entire work and two with details.)
 - » Please clearly name each photograph with surname and initial. If you have more than one entry please name each photograph with your surname and initial and title of artwork.
 - » No other reproductions or representations of artworks will be accepted.
 - A self addressed, stamped envelope of suitable size for the return of photographs.

4. Independent judges will pre-select entries by Thursday 1 April 2010. Successful artists will be notified as soon as possible after pre-selection.
5. Selected artworks will be received between 1 and 3 pm on Tuesday 27 April 2010 at Canning Town Hall Albany Highway (Cnr George St) Cannington
6. Pairs and multiple panel entries are considered as one entry, and must be measured and priced as a single unit. Pieces are not to be sold separately.
7. Entries for pre-selection are restricted to four entries per person and no more than two entries per category.
8. All 2-D works must be well-presented and, where necessary framed, with hanging devices attached. Size is not to exceed 1 metre x 1 metre. All 2-D work must be clearly marked on the back with the artist's name, phone number and/or email address, section, title of work and price.

All 3-D works must be well-presented, and must not weigh more than 25 kg and measure no greater than 1 metre x 1 metre x 1 metre. All work must be accompanied by a card detailing artist's name, phone number and/or email address, section, title of work and price.
9. All works (with the exception of the Youth Award) must be for sale. A commission of 25% will be charged on all sales.
10. All works must be the artist's own original work, completed within the last 12 months, and must not have won any previous awards.

11. The Canning Art Award Committee, the City of Canning and all sponsors accept no responsibility for breach of copyright laws.
12. The winning entry of the City of Canning Acquisitive Award will become the property of the prize donor. Those artists entering work in this award must accept that if the sale price is more than the prize, then the artist must accept the latter.
13. Delivery, collection and insurance are the responsibility of the artist. All reasonable care will be taken but no responsibility for loss or damage is accepted.

All work must be collected on Sunday 2 May between 4 pm and 6 pm. Works not collected within one month will become the property of the Canning Art Award. Receipt must be shown on collection.
14. Selection and judges' decisions are final and no correspondence will be entered into.
15. The artist agrees to allow any work to be reproduced in part or in whole by print or electronic media only for the promotion of the Award. Copyright remains the property of the artist.
