No late entries will be accepted.
3. Applicants are to submit:
  - A completed application form including entry fee, which must show name, address, phone number, email address (if applicable), title, section and price.

4. Artworks will be received between 8.30 and 10.30 am on Wednesday 6 June 2012 at

5. Pairs and multiple panel entries are considered as one entry, and must be measured and priced as a single unit. Pieces are not to be sold separately.
6. Entries are restricted to two entries per person.
7. All 2-D works must be well-presented and, where necessary framed, with hanging devices attached. Size is not to exceed 102cm x 102cm. All 2-D work must be clearly marked on the back with the artist's name, phone number and/or email address, section, title of work and price.  
  
All 3-D works must be well-presented, and must not weigh more than 25 kg and measure no greater than 100cm x 100cm x 150cm. All work must be accompanied by a card detailing artist's name, phone number and/or email address, section, title of work and price.
8. All works (with the exception of the Youth Award) must be for sale. A commission of 25% will be charged on all sales.
9. All works must be the artist's own original work, completed within the last 12 months, and must not have won any previous awards.
10. The Canning Art Award Committee, the City of Canning and all sponsors accept no responsibility for breach of copyright laws.
11. The winning entry of the City of Canning Acquisitive Award will become the property of the prize donor. Those artists entering work in this award must accept that if the sale price is more than the prize, then the artist must accept the latter.
12. Winners of Sections 1-5 will be ineligible for this award.
13. An Emerging Artist is defined as someone who, regardless of age, has not had a solo exhibition; does not teach, or has not taught any form of art; has not won an art prize of \$1000 or more.  
Winners of Sections 1-5 will be ineligible for this award.
14. Delivery, collection and insurance are the responsibility of the artist. All reasonable care will be taken but no responsibility for loss or damage is accepted.  
  
All work must be collected on Sunday 17 June 2012 between 4 pm and 6 pm or they will incur transport and storage costs. Any work remaining after 1 month will become the property of CAG. Receipt must be shown on collection.
15. Judges' decisions are final and no correspondence will be entered into.
16. The artist agrees to allow any work to be reproduced in part or in whole by print or electronic media only for the promotion of the Award. Copyright remains the property of the artist.
17. Works that do not conform to size or hanging requirements or is wet will not be accepted.
18. No photographic or digitally produced pieces will be accepted in any section.

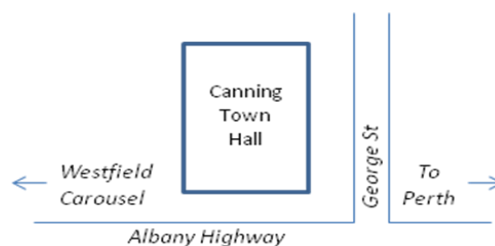
